It was agreed that we would discuss this with our new groundsman when he joins in September.

It was agreed that expert advice is much needed as we have been developing Feldy in an ad-hoc way for 20 years and it is time for a pre-determined plan. It was agreed to have an initial discussion at a likely cost of £600 and then budget next year for costs of up to £5000, dependent on the survey.
