### 23/069 APOLOGIES FOR ABSENCE

Apologies were received from Councillor Sylvia Wargent. Apologies were received from Borough and County Councillors as they are attending a meeting in Colchester. No vote was taken.

The Council RESOLVED to agree that the West Mersea Town Meeting be postponed to a date outside of the pre-election period.

### 23/076 CLLR POWLING PROPOSES TO ACCEPT THE FOLLOWING COSTS FROM NEPP TO CARRY OUT THE FOLLOWING WORKS TO BE FUNDED BY THE DEVOLUTION FUND

- 1. Double yellow junction marking for:
  - a. Firs Road / High Street North
  - b. Mersea Av / High Street North
  - c. Lower Kingsland / Kingsland Close
  - d. Lower Kingsland / Goings Lane
  - e. St Peters Road / Mersea Av
- 2. Dead end signage / no park access for cross lane

Cllr Powling advised that Essex County Councillor Lee Scott, portfolio holder for highways advised in a meeting with Councillors that Devolution funding could be kept, but it must be used on highways. Devolution

funding could be used for junction protections and signage.

Cllr Akker advised that NEPP did not give a reason for rejection for the Council's proposal but requested £9000. Proposed add New Captains Road and Seaview/Esplanade to this list.

The Council RESOLVED to accept NEPP costs of £3300 for the six junction protections and for signage at £280.

### 23/077 CLLR POWLING PROPOSED TO DONATE THE REMAINDER OF THE COVID ACCOUNT TO THE PORCH PANTRY

The Council RESOLVED to donate the £304 remaining in the covid account to the Porch Pantry.

### 23/078 COLCHESTER ROAD IRON SIGN REFURBISHMENT

To discuss and agree to fund the material refurbishment of the Colchester Road direction sign from the Devolution fund to a maximum cost of £1500.

Cllr Powling advised that the Colchester Road Iron Sign is an Essex County Highways sign and do not want to refurbish and are happy for it to be replaced/refurbished, put to the Council as a heritage project.

The Council RESOLVED to agree to fund the Colchester Road Iron sign refurbishment from the Devolution fund to a maximum cost of £1500.

Cllr Bragg, Cllr Akker and Cllr Baker abstained. Cllr Wood opposed spending of Council money.

# 23/079 TO CONSIDER A SUGGESTION FROM NEPP TO LEAVE OPEN OVERNIGHT IN THE SUMMER MONTHS BOTH WILLOUGHBY AND ESPLANADE CAR PARKS AND TO CHARGE AN OVERNIGHT RATE OF £1 FROM 6PM TO 8AM

Discussions were held about public concern with leaving the car parks open overnight, including travellers and drug dealing. The employee that was paid to open and close the car park 7 days per week is no longer working and this is not suitable for a volunteer position. Considerations including solar powered CCTV and automatic barriers were discussed.

The Council RESOLVED to advise NEPP that the car parks should be locked overnight, and that new signage should be put in place.
